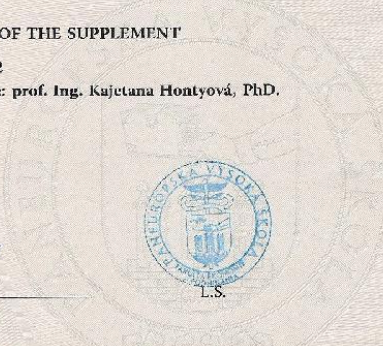

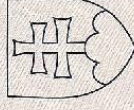

## SYSTÉM VYSOKÉHO ŠKOLSTVA V SLOVENSKEJ REPUBLIKE

Všeobecné požiadavky na prijatie na štúdium na vysokej škole spĺňajú absolventi strednej školy s vysvedčením o maturitnej skúške vydaným po úspešnom vykonaní maturitnej skúšky po absolvovaní spravidla 13, výnimočne 12 rokov štúdia.

Vysoké školy spravidla organizujú aj prijímaciu skúšku.

### Štúdium na vysokých školách

Vysoké školy poskytujú študijné programy troch stupňov:

1. Bakalársky študijný program, ktorý trvá najmenej tri roky a najviac štyri roky (architektúra, výtvarné umenie a dizajn).
2. Magisterský, inžiniersky a doktorský študijný program. Štúdium trvá najmenej jeden rok a najviac tri roky tak, aby štandardná dĺžka štúdia podľa bakalárskeho študijného programu a nadväzujúceho programu 2. stupňa v tom istom alebo príbuznom študijnom odbore predstavovala spolu najmenej 5 rokov. Môže sa uskutočňovať aj ako súvislé štúdium spájajúce prvý a druhý stupeň vysokoškolského vzdelávania. V tomto prípade je štandardná dĺžka štúdia najmenej 4 roky a najviac 6 rokov.
3. Doktorský študijný program. Štandardná dĺžka štúdia v dennej forme je najmenej tri roky a najviac štyri roky, v externej forme najviac päť rokov.

### Rigorózne skúšky

Absolventi s akademickým titulom magister môžu vykonať rigoróznou skúškou, súčasťou ktorej je aj obhajoba rigorózne práce. Po jej úspešnom vykonaní vysoké školy udeľujú tieto akademické tituly:

- doktor prírodných vied (RNDr.) v prírodovedných študijných programoch
- doktor farmácie (PharmDr.) vo farmaceutických študijných programoch
- doktor filozofie (PhDr.) v spoločenskovedných a umenovedných študijných programoch
- doktor práv (JUDr.) v právnických študijných programoch
- doktor pedagogiky (PaedDr.) v učiteľských študijných programoch a (tových)ovných študijných programoch
- doktor teológie (ThDr.) v teologických študijných programoch okrem študijných programov v oblasti katolíckej teológie

Kreditový systém (od akademického roka 2002/2003)

Štandardná záťaž študenta za celý akademický rok je vyjadrená počtom 60 kreditov, za semesť 30 kreditov a za trimester 20 kreditov.

Podrobnosti známok podľa tohto systému rozlišuje šesť klasifikačných stupňov:

- A ( výborne)	= 1 (vynikajúce výsledky)
- B ( veľmi dobre)	= 1,5 (nadpriemerné výsledky)
- C ( dobre)	= 2 (priemerné výsledky)
- D (uspokojivo)	= 2,5 (priateľné výsledky)
- E (dostatočne)	= 3 (výsledky spĺňajú iba minimálne kritéria)
- FX (nedostatočne)	= 4 (výsledky nespĺňajú ani minimálne kritéria)

Vysoká škola alebo fakulta, ak sa študijný program uskutočňuje na fakulte, môže pri vybraných predmetoch rozhodnúť, že sa nebudú hodnotiť známokou a určiť iné kritériá na ich úspešné absolvovanie ako podmienky na získanie kreditov.

## HIGHER EDUCATION SYSTEM IN THE SLOVAK REPUBLIC

The general prerequisite for admission to higher education study is secondary school-leaving certificate (vysvedčenie o maturitnej skúške) issued after passing the secondary school-leaving examination taken upon completing 13, exceptionally, 12 years of study.

Higher education institutions organise as a rule the admission examination.

### Study in higher education institutions

Higher education institutions provide the study programmes at three levels:

1. The Bachelor's study programme which takes three years at least and four years at most (architecture, fine art and design).
2. The Magister's, Engineer's and Doctor's study programme. The study takes one year at least and four years at most so that the standard length of study according to the Bachelor's study programme and the continuing programme of the second level in the same or relative field of study represented in total five years at least. It may be also carried out as a continuous study connecting the first and second level of higher education. In this case the standard length of study is four years at least and six years at most.
3. The PhD. study programme. The standard length in full-time form is three years at least and four years at most, in part-time five years.

- doktor všeobecného lekárstva (MUDr.) in the field of general humane medicine
- doktor zubného lekárstva (MDDr.) in the field of dentist humane medicine
- doktor veterinárskeho lekárstva (MVDr.) in the field of veterinary medicine

### 3<sup>rd</sup> level

- doktor -philosophiae doctor (PhD.)
- doktor umenia -artis doctor (ArtD.)
- licenciát (Catholic) teológie (ThLic.)
- doktor (Catholic) teológie (ThDr.)

### Examina rigorosa

The holders of the academic degree of magister may take *examina rigorosa*, which includes also the defence of a rigorosa thesis. After its successful completing the higher education institutions award the following academic degrees:

- doktor prírodných vied (RNDr.) in natural science study programmes
- doktor farmácie (PharmDr.) in pharmacy study programmes
- doktor filozofie (PhDr.) in social science and art science study programmes
- doktor práv (JUDr.) in law study programmes
- doktor pedagogiky (PaedDr.) in teacher training and sports study programmes
- doktor teológie (ThDr.) in theological study programmes except for the study programmes in the field of Catholic Theology.

Credit system (since Academic year 2002/2003)

The standard load of the student for the entire academic year is expressed by number of 60 credits, for semester 30 credits and for trimester 20 credits.

The higher education institution or faculty, if the study programme is carried out at the faculty, may at selected subjects decide not to assess students by marks but to set instead the other criteria for their successful completion as a condition for accumulation of credits.

Na hodnotenie celkových študijných výsledkov študenta vo vymedzenom období sa používa vážený študijný priemer. Vypočítava sa tak, že v hodnotenom období sa zrážajú účinný počet kreditov a číselného hodnotenia pre všetky predmety zapísané študentom a výsledok sa vydelením celkovým počtom kreditov zapísaných študentom za dané obdobie. Za produkty, ktoré si študent zapísal a neabsolvoval, sa do váženého priemeru započíta známka 4. Predmety, ktoré nie sú hodnotené známkou, sa do výpočtu váženého študijného priemeru nezahŕňajú.

Akademický rok sa začína 1. septembra bežného roka a končí sa 31. augusta nasledujúceho roka. Skladá sa z dvoch semestrov (zimného a letného) alebo z troch trimestrov. Organizácia akademického roka je stanovená štatútom fakulty alebo štatútom vysokej školy, v prípade, ak sa vysoká škola nečlení na fakulty.

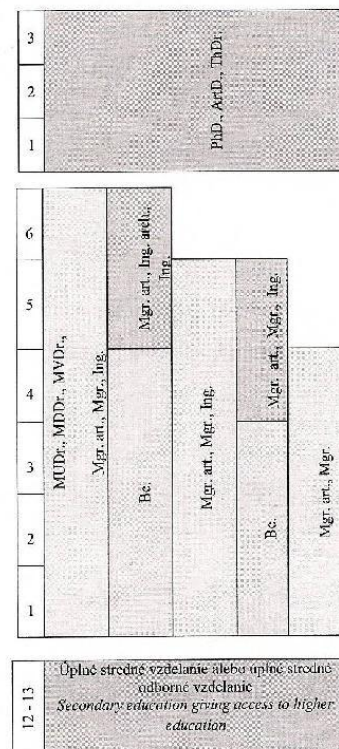

For assessment of overall study achievements of the student in a determined period a weighed study mean is used. It is calculated in such a way that in the assessment period the products of number of the credits and numerical assessment are summed up for all subjects ascribed to students and the result is divided by total number of credits achieved by the student during the given period. For the subjects which the student enlisted for and did not complete mark 4 is added up to the weighed mean. The subjects which are not evaluated by a mark are not included in calculation of the weighed study mean.

The Academic year starts on September 1 of the current year and ends on August 31 of the following year. It is composed of two semesters (winter and summer) or from three trimesters. The organisation of academic year is set by the statute of the faculty or statute of the higher education institution, if the higher education institution is not divided into faculties.
